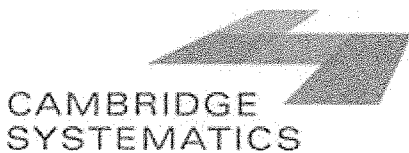

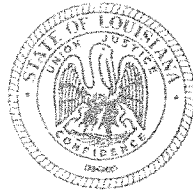

Dear Sir/Madam:

I have had the pleasure of working with Major Carl Saizan for the last ten years. I first had the opportunity to work with Carl when he was Captain Saizan, Commander of Troop B and I was Chief of Parish Courts for the Jefferson Parish District Attorney's Office. Captain Saizan wanted to meet monthly to review any issues the District Attorney's Office had regarding State Police reports or cases that went to trial. He expanded the meeting to include other agencies and make it more of a training venue. Captain Saizan was instrumental in helping us establish the No Refusal Program in Jefferson Parish and then expanded it to the other State Police Troop areas. He continues to be a strong advocate of the search warrant procedure by speaking to other agencies and judges in the state to encourage them to implement the No Refusal Program in other parishes.

Major Saizan and I are Team Leaders of the Impaired Driving Emphasis Area for the Louisiana Strategic Highway Safety Plan. A Strategic Highway Safety Plan is a state's comprehensive transportation safety plan. The primary goal of an SHSP is to reduce fatalities and serious injuries on all public roads. It is a data-driven, multidisciplinary plan that establishes statewide performance measures, goals, objectives, and emphasis areas and describes a program of strategies to reduce or eliminate safety hazards. Based on analysis of the data and other considerations, the Louisiana Department of Transportation and Development (DOTD), Louisiana State Police (LSP), and the Louisiana Highway Safety Commission (LHSC) recommended adoption of four emphasis areas for focusing attention, energy, and resources: 1) Impaired Driving; 2) Occupant Protection; 3) Infrastructure and Operations; and 4) Crashes Involving Young Drivers.

Although Major Saizan is a Team Leader of the Impaired Driving Emphasis Area Team, he is very involved in all of the other emphasis areas. The goal for the Impaired Driving Emphasis Area Team and each emphasis area is to reduce fatalities and injuries by no less than 50 percent by 2030. As Team Leaders, I work very closely with Major Saizan and I can tell you that there is no one more committed to achieving these goals.

Major Saizan is the most dedicated law enforcement officer with whom I have had the pleasure of working. He has dedicated his life to making our community safe and his priorities continue to be preventing deaths and injuries on Louisiana roads. His commitment is not limited to when he is on duty; he attends meetings and events even on his days off. I believe that Major Saizan is very deserving of recognition for his lifetime of outstanding achievement in the realm of highway safety. We are very fortunate to have such a strong highway safety champion in Louisiana!!!
